## High School Enrichment (non-CCAP)

### Enrollment Form

---

The student named below is recommended as a high school enrichment (non-CCAP) community college student to undertake course(s) of instruction offered at the community college level. The goal of this recommendation is to expand high school enrichment opportunities, including continuation high school and charter school to community college for career technical education or preparation for transfer, improve high school graduation rates, or help high school pupils achieve college and career readiness.

**The following conditions are associated with admission as High School Enrichment (non-CCAP):**

- The course content is not altered and is intended for adults;
- The student is treated as an adult, and is expected to act in a mature manner in the classroom;
- Grades earned are entered onto the student's permanent college transcript;
- Parents must communicate with their son/daughter regarding academic progress and not with the instructor or other college personnel;
- Students should enroll in college-level coursework;
- Students can enroll up to a maximum of 11 units per term (note: if enrolled in both CCAP and Non-CCAP, there is an eleven (11) unit limit);
- A high school pupil enrolled in a course shall not be assessed any fee that is prohibited by Section 49011;
- No physical education courses may be taken or any course opportunities that do not assist in obtaining career technical education or preparation for transfer, improving high school graduation rates, or helping high school pupils achieve college and career readiness.

#### STUDENT AGREEMENT:

By signing below, you acknowledge you have read and understand the following:

- All SCCC High School Enrichment students are responsible for complying with the rules and regulations of the college as published in the FCC/RC/CCC/MCC catalog(s) and schedule(s) of classes. Please review these rules and regulations with your parent or guardian to ensure you have a successful experience.
- Grades: By participating in a high school enrichment course, you are creating a college transcript. The grade(s) you earn in your SCCC class(es) will become a part of your official college academic record.
- Students participating in High School Enrichment must make satisfactory academic progress (minimum cumulative GPA of 2.0 and completion of 51% of courses attempted).
- For financial aid eligibility after high school graduation, students must make satisfactory academic progress (minimum cumulative GPA of 2.0 and completion of 51% of courses attempted).
- I understand that SCCC will not release my final grades to my high school registrar. As per 49601 of the Education Code, my college records will not be released to anyone without my written consent. (Family Educational Rights and Privacy Act [FERPA]). Authorization to Release Student Information form may be obtained at Admissions & Records. Transcripts may be ordered online.
- I understand that if I am enrolled in CCAP and high school enrichment (non-CCAP) classes there is an eleven (11) unit limit per semester.
- Students with Disabilities Accommodations: Accommodations for students with disabilities are by regulation different for college classes than for high school classes.
